

The Youth Initiative

SUSTAINING OUR COMMUNITY FOR THE NEXT GENERATION

In early 2009, the Sonoma Valley Fund established a Youth Initiative Committee to explore the many challenges facing Sonoma Valley's youth, and to attempt to address important community concerns such as the perceived low numbers of local high school students going on to college or meaningful jobs, continuing reports of significant drug and alcohol problems among Valley youth, and disappointing levels of academic performance versus comparable schools around the state.

Over a nine-month period, the Committee met with more than sixty people, all of whom are intimately involved with youth issues in Sonoma Valley, including middle and high school students, parents, heads of youth-oriented nonprofits, school administrators and teachers, local experts, philanthropists, and others who have been involved with youth issues for years. The outcome of these discussions was the development of specific recommendations to benefit Valley youth of all ages, with the primary focus on programs and activities directed at late elementary and middle school kids.

To implement the recommendations, Sonoma Valley Fund has formed a new Coordinating Council for Youth Development in Sonoma (CCYDS – pronounced Kids.) The Youth Initiative is an important example of ways in which the Sonoma Valley Fund works to strengthen our community, as we are uniquely positioned to organize consortiums, like CCYDS, where combined resources can accomplish a common purpose.

CELEBRATING COMMUNITY

Quarryhill Botanical Gardens was the setting for the Sonoma Valley Funds' annual celebration held on July 13 this past year, where the fund honored special volunteers selected by its non-profit partner organizations, recognizing them as "Sonoma Valley Stars." The range of volunteer activities performed by the awardees covers everything from cooking meals for teens, bringing cheer and flowers to those hospitalized and helping seniors prepare tax returns to spearheading fundraising events. Their levels of commitment and longevity of service as described by the presenting host from each organization are truly inspiring. This was SVF's third annual celebration for donors, nonprofit partners and community leaders. Over 200 guests wandered through Quarryhill's Asian woodland gardens, learning about its unique botanical species from Executive Director Bill McNamara and docents, while enjoying refreshments prepared by Sonoma Valley Fund's Board members and Advisors.

Grant Making in Sonoma Valley

In 2009 Sonoma Valley Fund, with Community Foundation Sonoma County and their donors, awarded \$265,550 to the local community in grants and scholarships. Sonoma Valley Fund awarded six grants from the George and Phyllis Ellman Fund totaling \$25,500, to support a diversity of work as shown here.

2009 SONOMA VALLEY ELLMAN FUND GRANTS

LANDPATHS - To support Flowery Elementary School 3rd grade program In Our Own Backyard connecting students with nature while also supporting broader education needs.

QUARRYHILL BOTANICAL GARDEN - To support environmental education tours for SVUSD 4th & 5th grade students at QBG, an Asian woodland comprised of wild-collected, species plants.

SONOMA ECOLOGY CENTER - To support the K-12 Watershed Education Project which delivers environmental science content and outdoor experiences for over 1,000 students per year.

SONOMA LAND TRUST - To flag and develop (with largely volunteer labor) two low-key, gentle loop trails through the back country of the Glen Oaks Ranch to make the property more accessible to visitors.

SONOMA LEAGUE FOR HISTORIC PRESERVATION - To present the newly renovated Hooker House to the public, installing exhibits, signs and creating brochures and schedules.

SONOMA CLASSICAL MUSIC SOCIETY - To assist in presenting classical music programs in Sonoma.
