For Community Foundation Sonoma County, 2008 was a year to take action. Like everyone, we were challenged by the new realities of the financial downturn. Our donors, grant recipients and community partners each faced tests that few had anticipated. In the midst of rising doubt, the Community Foundation responded once again by creating bridges, focusing on flexibility and resilience.

Where we couldn't invest dollars, we invested time. When we couldn't raise our funding, we raised our thinking. In the face of great adversity, we drew upon the strength of community. We learned new ways to meet the growing needs of our neighbors, and in the process, we made new friends. Much of our work centered on bolstering our nonprofit partners. We offered workshops on improving program outcomes, strategic planning, fundraising, branding and marketing, starting an endowment and launching a legacy society for planned givers. With this 2008 report, we introduce a smaller publication, reflecting our efforts to reduce expenses. Many of our lists traditionally printed here can be found on our website. Together with our donor advisors, we granted \$19 million to support the arts, education, the environment and human services. At the same time, we have begun new ways of collaborating on safety-net issues through initiatives such as Ending Family Homelessness.

We need you, as a member of our Community Foundation family, to engage in thoughtful dialogue, offering us your insights on the state of our society, helping us take action in these challenging times. DEISY'S STORY (15 year-old member of Community Action's Youth Leadership Project):



"My experience with CLACE was one of the best ever. I felt really good about helping people to get registered and realized how important it is to get people to vote, especially Latinos. It's an awesome feeling that we made history with our new president, County Supervisor and City Councilman — one African American and two Latinos."

Su Voto es Su Voz is emblazoned on the t-shirts worn by the youth volunteers from Community Action's Youth Leadership Project who canvassed five precincts in Roseland last year. They went door-to-door, encouraging residents to register and vote

in the November election. They also surveyed people on what could help them be more involved in their community. Registered voters increased by 13 percent, and more importantly, revealed valuable survey findings. People expressed strong interest in civic engagement but didn't understand how the political system works. Dissemination of clear community information is a first step.

"Investing in the integration of Latinos into the entire community means a better future for everyone. Like Deisy, many youth are ready for the task," said CLACE founding member Dr. Francisco H. Vázquez. Project funding came from a Community Foundation grant, a donor-advised grant and the Roseland Development Fund with project coordination by Community Action Partnership and the Hutchins Institute for Public Policy Studies at Sonoma State University. Elizabeth, another 15-year old volunteer says, "I feel very proud because it wasn't an easy job, but we made it happen!"

KAREN'S STORY:

"We lived in daily fear. I never knew when Mark would come home high or angry and attack us. The neighbors called the police many times, but often, he would be gone before they arrived. When I was seven months pregnant, he threatened me with a kitchen knife. Another time he beat me up and left me on the side of the road. The many times I was hospitalized because of him, I never told anyone that I was being abused, but they knew it."

Like every battered woman, Karen felt trapped. How would she support her kids? Where would they live? What would happen if Mark took them away?

With help from the collaborative support program offered by Legal Aid and the YWCA, Karen stopped the abuse. She sought counseling, emergency shelter and a housing voucher through the YWCA. With new courage, she filed a restraining order against Mark. Through Legal Aid, she obtained a 5-year protective order and the right to keep him away from her children and her home. *Wherever she goes, wherever she lives, she is now safe.*

Legal Aid and the YWCA have assisted domestic violence victims for years. Through a grant from the Community Foundation, they combined forces and increased their effectiveness ten-fold. Working together, they provide coordinated legal and emotional support with professionals and volunteers who accompany clients from their initial intake to the courtroom. Services to clients like Karen and her children have doubled in volume, resulting in more women and families like hers living in safety and rebuilding their lives.





The Ellman Fund

George and Phyllis Ellman are models for leading a passionate life. George invented the Ellman Reagent, a testing method which is now standard lab procedure for measuring enzymes and proteins. Like his love of science, his civic zeal led him to serve as mayor of Tiburon, advocate for a sustainable Sonoma County transportation plan and help Greenbelt Alliance set urban growth boundaries. His delight in playing the piano and harpsichord caused him to co-found the Sonoma Classical Music Society. George's wife Phyllis, who recently passed away, was passionate about native wildflowers and open space preservation. Tiburon's Phyllis Ellman Trail loops by *Calochortus tiburonensis*, the rare Mariposa Lily which she helped save.

In 2007, George and Phyllis discussed how to make a meaningful gift that would support their life-long passions for the environment, environmental education, historic preservation and classical music. Through a trusted friend, they learned that the Sonoma Valley Fund (SVF, see page 7) could provide the bridge between their needs and their dream. They could benefit from the financial stewardship of the Community Foundation, and the SVF Grants Committee could evaluate and award grants in their specified areas of interest.

In 2008, the Ellman Fund awarded grants totaling \$25,000. "We hope our Fund will illustrate the possibilities offered by the SVF and inspire others to activate their giving," says George.

BOB'S STORY:

"Even though I'd been a successful contractor for most of my adult life, the loss of my wife to cancer was devastating and left me homeless at the age of 53. I was living out of dumpsters and felt so small standing in line for the first time to get a free meal handed to me. It took a giant step for me to enter the Mary Isaak Center (MIC) Emergency Shelter. I was so ashamed, but the understanding and empathy that they offered me changed my life. I got critical recovery help, health care and life skills training. The COTS folks wouldn't let me quit and I graduated from the MIC Transitional Housing program. Because of this, I now live independently, work full-time and help others suffering from hopelessness and homelessness to follow my path to success."

COTS rebuilds shattered lives through innovative cost-effective programs that are nationally recognized. Through a combination of structure and compassion, COTS has broken the cycle of homelessness for thousands like Bob since 1988. Named for COTS' co-founder, whose vision and legacy of deep caring inspires its work, the Mary Isaak Center provides help and hope to those who have lost both. The Mary Isaak Endowment Fund at the Community Foundation helps individuals and families by supporting their case management, money management courses, recovery programs, career development and transitional housing opportunities. The fund benefits from the Community Foundation's flexible, turn-key service, sound investment program and its commitment to addressing homelessness in our community.

Quarryhill Botanical Garden

A GLOBAL BRIDGE TO PRESERVATION

The long driveway from Glen Ellen's Highway 12 leads to a stone gate and a steep climb delivers you to the grand, arbored plateau. Rare Chinese roses arching over the surrounding rock walls are the first hint at something special. Peering east, the valley opens, inviting you to discover Quarryhill's magnificent woodland garden with lakes, waterfalls and nearly 2,000 species of Asian plants. Founder Jane Davenport Jansen, who created these gardens and sponsored over 20 international expeditions, left a legacy of preservation; Quarryhill is a virtual Noah's Ark for rare and endangered flora from East Asia, many with medicinal value. Seeds collected in the wild and propagated here for all to enjoy are ancestors of western garden favorites, including oaks, maples, dogwoods, lilies and roses.

After 20 years of carefully stewarding its endowment, the Garden's Board of Directors realized that they could benefit from outside financial expertise to better protect their funds. They also wished to increase the garden's visibility; enhanced awareness could net greater local engagement as well as new donors and board members. The small staff led by Executive Director Bill McNamara recognized their need for professional help with branding, fundraising and legacy planning if they were to grow their organization.

After thorough research, Quarryhill chose the Community Foundation; they also became a Nonprofit Partner with the Sonoma Valley Fund (SVF), its local branch affiliate. "We knew the Community Foundation could help us connect with the greater community and provide us with many professional resources; our funds would join a larger investment pool, giving us increased diversity, leverage and protection," said Board President Bob Smith. With grant support from the SVF's Ellman Fund (story on pg. 5), 4th and 5th graders now experience the garden as a living classroom and learn about our global crisis of plant extinction. "People simply fall in love with the garden once they come here," Smith exclaimed, "and we want more of that!"

HEALDSBURG AREA FUND

In 2008, the Healdsburg Area Fund provided Basic Operating Support grants in response to the challenging economic times and distributed \$40,000 to ten local organizations. With these grants, each organization had the flexibility to allocate funds to bottom line needs such as rent, utilities and operating expenses. This helped bridge unexpected revenue reductions and allowed the organizations to focus on providing essential services and programs.

Amber Twitchell, Economic Recovery Director for the California Human Development Corporation, explained that their grant went to support the Healdsburg Day Labor Center: "The freedom to use these grants to keep the doors open and the lights on strengthened our ability to provide services to the men and women who rely on us."

"We are grateful to the donors who have supported the continued growth of the Healdsburg Area Fund endowment," said Richard Burg, board chair, "With the uncertainties of state and federal funding, our support can span such gaps for addressing critical needs in Healdsburg and Geyserville."

SONOMA VALLEY FUND

To acknowledge the power of volunteering, the Sonoma Valley Fund (SVF) launched its Sonoma Star Awards, honoring individuals chosen by each of its eleven Nonprofit Partners. 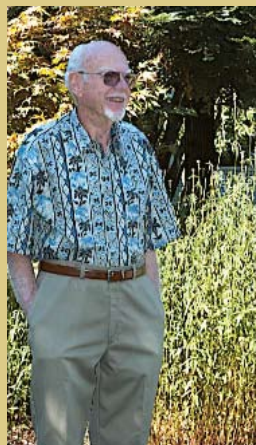

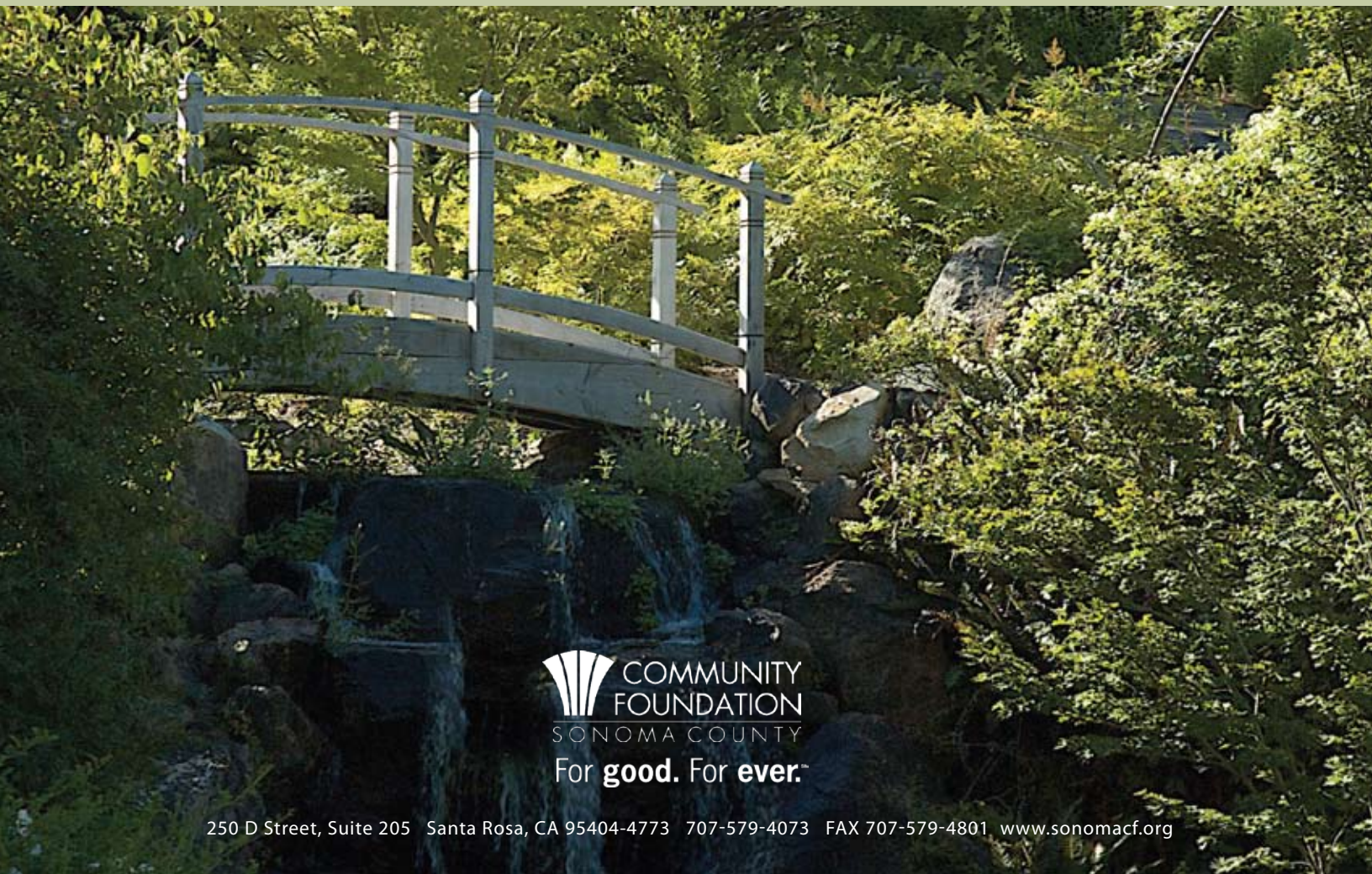

2008 COMMUNITY FOUNDATION SONOMA COUNTY GRANTS

The Community Foundation awarded \$1.56 million in grants, which comprises 8% of our total 2008 grantmaking. Included are our affiliates, the Healdsburg Area Fund and the Sonoma Valley Fund, which award grants in their local areas.

BASIC HUMAN NEEDS GRANTS

Catholic Charities: \$5,000 to provide food to low-income residents in rural areas.

The Living Room: \$5,000 to provide food and essential clothing items to homeless women and children.

North County Community Services: \$5,000 to provide subsidized apartment rentals for families facing imminent homelessness.

Petaluma Ecumenical Properties: \$5,000 to provide emergency assistance with rent, food and clothing to low-income seniors.

West County Community Services: \$5,000 to provide food to low-income people in crisis.

Sonoma County Adult and Youth Development: \$5,000 to provide short-term assistance for food, clothing, utilities and housing to residents of Rohnert Park and Cotati who are experiencing financial crisis.

River to Coast Children's Services: \$5,000 to provide emergency basic supplies, emergency child care, transportation assistance and shelter to low-income families.

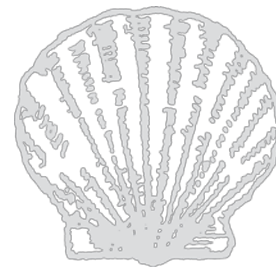
